1. Study Session - 4:30 pm

A. Long Range Planning, Demographic Study – Leon Wilcox, Business Administrator, Rick Brammer from Applied Economics

Rick Brammer from Applied Economics presented a demographic analysis and projections of the Canyons District geographic area to the Board of Education. The studies scope included demographic characteristics & trends, residential market impacts and demographic projections.

The school-age population of the District is expected to decline by about 2,400 person over the next 10 years. When based on only modest decline in the Service Rate, the District enrollment is projected to fall by around 2,100 students by 2033-2034 school year. The rise of online schools, the presence of charter schools and open enrollment policies are causing the share of the school-age population be served by the District to decline slightly. Enrollment is projected to decline steadily throughout the projection period, but lower housing prices or mortgage rates could help slow the loss. Presentation available on BoardDocs.

C. Title IX District Report – Tom Sherwood, Director of High Schools

53G-6-1101, -effective May 4, 2022, provides that each academic year, the athletic director, or another administrator of each school shall report to the school governing board. Mr. Sherwood discussed the three prongs of Title IX which include proportionality, expansion and accommodating interests and provided specifics for each of them for the District. If there is a discrepancy between male-designated and female-designated sports of 10% or greater, then an action plan will need to be developed to address the discrepancy.
