A. 2025 Legislative Update – Charlie Evans, Director of External Relations and Susan Edwards, Public engagement Coordinator

B. 2025-26 School Fee Schedule (First Reading) – Leon Wilcox, Business Administrator

HB415 passed in 2024, requiring that in FY26 registration fees for middle and high school may no longer be charged. CSD usually collects approximately \$950,000 per year in registration fees. Under HB415, CSD will likely be distributed about \$850,000, \$500,000 and \$350,000 over the three-year period. It has been established that fundraising is not considered a school fee.

HB344 passed the House on February 7, 2025, with significant support. It would require each LEA to have a path to graduation where a student can graduate without needing to pay fees starting in the 2026-2027 school year. HB344 defines fee and non-fee courses and eliminates confusing definitions of curricular and co-curricular fees. The bill will disallow LEAs from charging fees in non-fee, CORE courses.

The recommended high school fee schedule is to increase the cap from \$5,000 to \$6,000 and middle school aggregate will remain the same at \$500. Mr. Wilcox reviewed additional proposed school fee changes and potential future increases for 2026-2027. The proposed 2025-26 fee schedules will be sent to parents via Parent Square. C. Policy Update: Policy-100.01-Board Governance; Policy-200.02- Fiscal Accountability; Policy-300.01-School Access; Policy-300.09- Facilities Construction, Renovation, and Maintenance; Policy-400.28-Military Leave or Military Stipend (First Reading) – Jeff Christensen, Assistant Legal Counsel

Policy-100.01-Board Governance

The policy committee is recommending minor edits to clarify a board member may request an item to be placed on the agenda by notifying Board Leadership by email. In addition, clarification was added regarding protocol in the absence of the President.

Policy-200.02- Fiscal Accountability

This policy is updated to include time and effort provisions as required by federal law. The purpose of time and effort provisions is to demonstrate that salaries and benefits charged to programs accurately reflect effort performed, and it is a requirement and condition for receipt of federal funds. Additionally, it was proposed the dollar amount for Board approval for purchasing bids be increased from \$80,000 to \$120,000.

Policy-300.01-School Access

The policy requires an update to align policy with practice regarding distribution of exterior master keys, and security panel alarm codes under the direction of the principal.

Policy-300.09- Facilities Construction, Renovation, and Maintenance

This policy requires a minor update to edit the Committee Membership of the Small Capital Facilities committee membership to align it with current practice.

Policy-400.28-Military Leave or Military Stipend

The Policy Committee recommends making adjustments to increase military leave from 15 to 20 days, and military stipends to similarly increase in proportion.

Board of Education statement regarding HB267:

Last Friday, Utah Governor Spencer Cox signed HB267, titled "Public Sector Union Amendments," which eliminates collective bargaining for public employees. We recognize this bill may have created uncertainty for civil and public servants, including our teachers, education support professionals, and administrators. We want this much to be clear: As stated in CSD's Strategic Plan, the Canyons Board of Education and Administration remain committed to providing "the necessary support for all employees to be successful in their roles." Please know the new legislation does not diminish our commitment to and support of our employees. We truly appreciate and value the great work our employees do daily to build up the next generation. Throughout the years, Canyons employees have proven their dedication to providing our students a world-class education in clean, welcoming, and prepared learning environments. 8. New Business

A. First Credential presentation – Dr. Rich Nye (Governor Education Advisor)

Dr. Rich Nye, the Governor's Senior Education Advisor, presented information on HB260 Utah First Credential implementation. The shared goal is to ensure every Utah high school student graduates with a credential that prepares them for college and the workforce, by uniting State K-12 and higher education agencies in a comprehensive, collaborative effort. The bill provisions were reviewed, such as develop Utah's First Credential Master Plan, establish and maintain the master credential list. B. SHARP Survey Update – Dr. Brian McGill, Director of Student Wellness Services

The Student Health and Risk Prevention (SHARP) mission is to ensure each student is safe, healthy and ready to learn. CSD's Holistic School Safety Framework and Standard Response Protocol is comprised of intervening early, averting violence, supporting student wellness, preventing bullying, ensuing online safety and improving school climate. Schools are providing nearly all aspects of Maslow's hierarchy of needs but the key for every student is what intrinsically motivates them. The goal is to help students learn how to be an optimal learner.

Participating in the SHARP's survey has helped create a collaborative partnership for CSD with the State of Utah, Department of Health and Human Services, Division of Substance Abuse and Mental Health, local cities/municipalities and Bach Harrison, LLC. The SHARP's survey provides the District with an assessment of needs through data collected from the survey every other year from students in 6th, 8th, 10th and 12th grades.

The participation in the survey allows the District to apply for grants that require it, resulting in \$8-10 million, which a is a major funding source for personnel. Presentation available on BoardDocs. https://go.boarddocs.com/ut/canyons/Board.nsf/goto?open&id=DDSVEB805DB0

C. Consideration for adoption of a resolution for the Board of Education of Canyons School District, Utah, authorizing the issuance and sale of not more than \$25,500,000 principal amount of its Refunding Bonds 2025A and related matters (First Reading) – Leon Wilcox, Business Administrator

The refunding transaction proposed will reduce the repayment time frame from 8 to 6 years on bonds issued in 2015. This refunding is projected to save approximately \$850,000 net present value, if approved. Refunding will allow more greater financial flexibility beginning in 2032, however will lessen the flexibility in years 2030 and 2031. As part of the federal government's debt reduction plan, they may eliminate tax-exempt state and municipal bonds and make all bonds taxable resulting in a negative impact on school districts issuing bonds in the future.
