# 2. Study Session - 5:30 pm

A. Policy Update: Policy-500.22—School Fees; Policy-300.08—Service Animals in Schools; New Policy-300.15—Animals in Schools; Policy 500.23—Extra-curricular Activities and Student Participation; New Policy-500.25—Field Trips (First Reading) - Jeff Christensen, Assistant Legal Counsel

Policy-500.22—School Fees

This policy will be edited to include updated definitions pursuant to HB415(2024) and HB 344 (2025). The fee schedule will be approved by April 1<sup>st</sup> for the following school year. There was also a fee provisions update for district, elementary and secondary schools.

## Policy-300.08—Service Animals in Schools

The Policy Committee recommends adding additional detail to this policy to include general provisions for service animals and safety in schools, guidance for staff members for interactions with service animals and owner responsibilities for service animals in schools.

# New Policy-300.15—Animals in Schools

The Policy Committee recommends a new policy to provide guidance regarding animals in schools that are not service animals. Trained therapy animal dogs may be allowed on school campuses or specific areas of a school, small animal classroom pets may be allowed in schools in accordance with the provisions. If a dog is not a service animal or therapy animal, for safety and hygienic reasons, dogs, whether leashed or not, are not allowed on school or district property.

# Policy 500.23—Extra-curricular Activities and Student Participation

The Policy Committee recommends an update to the policy to include the definition of extracurricular activity as outlined in HB344 2025 School Fee Amendments.

# New Policy-500.25—Field Trips

To simplify Policy 500.24 – Student Educational Travel, the current regulation regarding field trips will be developed into its own policy. The Board recognized field trips are an integral part of the District's instructional program and may be provided to enrich or expand learning opportunities for students. Field trips shall be used to visit a variety of civic, cultural, community and business resources within the reach of the classroom. Within funding limitations, it is the policy of the Board of Education to assure all schools have an equal opportunity to receive bus service for field trips.

B. 2025-26 Bell Schedule (First Reading) – Leon Wilcox, Business Administrator

The HB161 School Bus Route Amendment moves the eligible reimbursement for transportation for 6<sup>th</sup> graders if they are in middle school to 2.0 miles rather than 1.5 miles. All middle school bus stops will now be at least 2.0 miles from the school.

There are no proposed changes for the 2025-26 elementary bell schedule. There are no proposed changes for the 2025-26 bell schedule from the 2024-25 bell schedule for secondary schools. Corner Canyon is researching the possibility of starting at 7:45am and building advisory into the bell schedule. C. Updates to 2025-2026 School Calendars (First Reading) – Director of Human Resources, Steve Dimond

The Administration and School Calendar Committee are proposing a revised 2025-2026 School Calendar K-12. The proposal includes an update based on a change in State code, moving the first day of Kindergarten to Wednesday, August 20, 2025. This adjustment allows for additional time dedicated to individualized testing and evaluation. A change in Parent-Teacher Conferences to three days while rotating the day PTC is held between levels requires an

adjustment. In addition, an update will be made to convert two additional instruction days, for a total of four days for professional development.

A revised Brighton High School calendar is being proposed to change the first Parent Teacher Conferences to October 2, 2025, to accommodate extra-curricular activities and homecoming for 2025 and converting two additional instructional days, for a total of four days, to professional development days as allowed by State Code. #### 9. New Business

A. Long Range Planning Update – Study of Boundary Enrollment, School Consolidation and Potential School Closures (First Reading) – Leon Wilcox, Business Administrator

There continues to be a decline in enrollment and reports show that from 2018-19 to 2024-25 there has been a decline of 1,724 elementary students in Canyons School District. There are two major reasons cited for the decline, which are increasing housing prices/interest rates and the declining birth rate. The preferred elementary school size is a least three classes per grade, with four classes being the optimal. This would make the preferred elementary size of 425-567 students per school. The District currently has 10 schools under 375 students per school. The Facility Condition Index (FCI) score was shared for each of these 10 schools. The average operating costs for an elementary school, large or small enrollment, is approximately \$1,203,300 million per year.

The complexity of the Dual Language Immersion (DLI) impact was reviewed. Spanish remains a popular option but enrollments for Chinese and French are declining. DLI is the most expensive program offered by the District which requires a supplement of 15 FTE's or \$1.6 million per year.

The boundary study timeline, Utah Code 53G-4-402(24) was reviewed. The District is considering options to addressing the declining enrollment through studying boundary changes, school consolidations and potential school closures. A study of the DLI, which is considered a special enrollment program, will be reviewed to consider consolidations or closure of the

program. Information will be sent to all parents whose boundaries may be affected. Also, open houses will be scheduled for the 2025-2026 school year to inform parents and staff of information impacting their schools. B. Emergency Management Team Update – Jeff Haney, Director of Communications

The Emergency Management Team (EMT), is made up of the members of the Board of Education, District Administrators, and representatives of the schools and their purpose is to continuously evaluate safety plans and protocols in the District. This team oversees the crisis response guidelines for coordination, checklist, practice drills and site-specific safety plans. The Board of Education's facility-improvement plan allowed CSD to rebuild schools with safety in mind. CSD schools are built seismically safe, have state-of-the-art surveillance systems, and automatic locks that require employees to have ID badges to gain entry.

The District provides the community with incident response and updates through informing the Board, Cabinet, and District Operations Team. A team is dispatched to the scene for on-the-ground updates, provide information and work with first responders. The Student Wellness Service Department evaluates the need for crisis counseling at the scene and support at the schools. Parents receive information about the incident. Notes from the debrief with school employees and responding staff are shared with the EMT.

The current school safety projects include, school safety specialists (HB61), Guardian program, panic buttons, bullet resistant glass (HB84), school safety amendments passed during 2025 legislature (HB40), TCU Alert notification system, ID badge information repository, and doorcheck assignments. C. Update on the Superintendent Listening Tours - Superintendent Rick Robins

Dr. Robins addressed topics such as class sizes, facility needs, Special Education, support staff, and English learners that have been brought to his attention during the Superintendent listening tours. Additional feedback during the tours included teacher appreciation for additional planning time, fallout from unfunded mandates from the Legislature, addressing tech issues and concerns in schools, and employee health benefits. D. IT committee Update and Discussion – Superintendent Rick Robins

The District has been a "Common Sense" school district for four years, committed to teaching digital citizenship and the responsible use of technology. This program requires professionally trained teachers, teaching all students across two grade levels six digital citizenship lessons or teaching all students across three grade levels three digital citizenship lessons. School-based Digital Citizenship Coordinators share monthly tips/resources with families.

Canyons is committed to partnering with parents and will be seeking input on preferred Chromebook filtering practices for elementary schools, now through April 30, 2025. The district is asking for feedback from School Community Councils, building leadership teams, individual

parents and employees can also provide input through the "Your Schools, Your Voice" portal on the CSD website and feedback will also be accepted at <a href="mailto:communications@canyonsdistrict.org">communications@canyonsdistrict.org</a>.

The Administration is recommending going out for an RFP for a technology filtering system, do a deep dive on third party app agreements, explore a three strike suspension for student inappropriate searches and determine other appropriate levels of discipline for misuse of technology.
