A. Canyons Innovation Center Update and Naming/Branding Discussion (Second Reading) – Superintendent Robins

The Board of Education has authority and responsibility to name all new buildings, building remodels, or other facilities within the District. The Board has received input from stakeholders, a student workgroup, industry focus groups, committee consideration and Board involvement in the process of naming and branding. The target audience includes students, parents, employers, higher education and taxpayers. Some names suggested include Amplus, Spectra, Prisma, Synergixx, Spectratec and Lumus. Names under consideration are Synergy, Nexus, Confluence and the name Wave was brought up. The right modifier isn't just a label, it sets the tone for how the community, students and faculty will experience and refer to this place for years to come. The District will continue to engage with Gardner Design and the unveiling, groundbreaking is slated for October 2025.
