

# CANYONS SCHOOL DISTRICT MINUTES OF BOARD OF EDUCATION MEETING

The following minutes are a summary of the October 16, 2025, Canyons Board of Education Public Hearing.

The Board of Education of Canyons School District met in a public hearing on Tuesday, October 16, 2025, beginning at 6:00 pm at Bell Vista Elementary, 2131 East 7000 S., Salt Lake City, UT 84121.

### 1. Public Open House - 6:00 p.m.

A public open house was held with information displayed for patrons to regarding the boundary study.

#### 2. Presentation/Patron Comments - 6:30 p.m.

Mr. Wilcox reviewed information regarding the boundary changes and school consolidation/closures. The District is studying boundaries to maintain optimal class sizes and a full menu of academic opportunities for every child.

The District's funding is based on state-legislated formulas. The largest funding sources is the Weighted Pupil Unit (WPU). For every student enrolled for 180 days in 2024-2025, the District will receive \$4,674 per student from the state for the 2025-2026 school year. With an estimated 659 fewer students for the 2025-2026 that equals \$3.2 million less funding for the district in 2026-27...

Mr. Wilcox reviewed where the District has been preserving funding for schools through absorbing district level administrative position, reassigning district office employees to work in the schools, delaying technology and equipment replacements to extend their use, placing a hiring freeze and prioritizing positions for employees if schools are consolidated.

Canyons has been subsidizing small schools to maintain staffing. Continuing to do so long term pulls funding away from other schools affecting class sizes, electives and student support elsewhere.

The Northeast Region proposal recommendation would include the westernmost portion of Ridgecrest Elementary School's boundary (West of 1300 E.) and would shift to East Midvale Elementary to align with Midvale Middle School's boundaries. This recommendation would close Bella Vista Elementary and combine with Ridgecrest Elementary in the Ridgecrest building. Alignment of middle school feeders would include Oakdale Elementary would have two feeder patterns (Oakdale>Albion>Brighton) and (Oakdale>Union>Hillcrest). All of Brookwood Elementary students would attend Albion Middle. All of Silver Mesa Elementary would attend Union Middle.

Considerations for combining schools include the capacity Bella Vista is 53,400 sq feet with 21 classrooms and Ridgecrest is 61,500 sq feet with 28 classrooms. These plans would require transportation for Bella Vista students to Ridgecrest and for Ridgecrest students to East Midvale.

Preschool and Special Education units are currently under review to explore where to locate early childhood classrooms and SPED unit to best serve families and balance enrollment.

Future planning considerations include school rebuilds under study. There are many factors that this decision would depend on such as construction costs, interest rates, enrollments, building age and condition, debt repayments, taxable values of property etc.

School choice permits and proposed boundary changes to accommodate the school-transfer request for students impacted by boundary changes or school consolidations were reviewed.
