1. Closed Session – 4:30

2. Study Session – 5:00 pm

A. Report on Utah College Application Week - Tori Gillett, Comp Guidance Specialist

Ms. Gillett had students, Sophie Jensen and Opportune Heath, from Brighton High School, speak about their experiences with Utah College Application Week (UCAW). UCAW helped 1,400 students apply for college during the designated time at their schools. She reported that \$1,960 was provided by the Canyons Education Foundation to help students apply for colleges. This amount is lower than the past due to some colleges providing free applications for students during UCAW. The students are encouraged to plan and sign up for a 1 year, 2 years, or 4 plus

years of college, which include other types of post-secondary options such as military or cosmetology school.

B. Update on IT plan and Digital Citizenship report – Scot McCombs, IT Director; Kenna Sorensen, Assistant ISD Director; Susan Edwards, Community Engagement Coordinator

CSD is now one-to-one with technology devices. Secondary students are assigned Chromebooks which they use at school and home. Elementary students have devices which they use at school. The Information Technology Department provides support to students and staff with school-based field techs in each secondary school, one for every 3 elementary schools, and 10 part-time tech assistants and interns are assigned to high schools. Mr. McCombs reported that 12% of the district does not have adequate home connectivity despite providing hotspots, comcast internet essential, Eduroam and private LTE. The IT department applied for emergency connectivity funds and was awarded \$4,230,789 in funding for purchasing 15000 Chromebooks to replace outdated devices, additional hotspots and Comcast. The department is experiencing issues with delays in the supply chain, excessive changes in staff transitions and turnover, continual need of funding for repairs and replacing technology as well as requests for filtering access to certain sites.

Ms. Kenna Sorensen reviewed House Bill 213, Safe Technology Utilization and Digital citizenship. The purpose is to educate students and parents on making smart media and online choices as well as safe technology practices. The responsibility of the Digital Citizenship Coordinator at each school includes addressing top concerns for their school, prepare students with 21st century skills, support educators with training and engage the whole community through family outreach. CSD Digital Citizenship week was held October 18-21, 2021 and included posters and resources distributed to all schools with highlights of the six strands of digital citizenship, lessons and daily announcements. Information regarding digital citizenship is presented by the Coordinator to the SCC and faculty at each school. The school then submits a report to the district. B. Policy—600.02—Curriculum Adoption; and Policy—600.06—School Library Media Selection and Review (Second Reading) – Amber Roderick-Landward, ISD Director

Policy—600.02—Curriculum Adoption

The review of the curriculum adoption policy includes substantive revisions to outline the adoption of Instructional Materials in CSD. The policy will be retitled "Instructional Materials" and includes an exhibit for the process of instructional materials adoption for each of the levels outlined in the policy. A parent or legal guardian may request a waiver for their child's participation in a portion of the curriculum or activity as outlined in state statute. Dr. Roderick-Landward reviewed the process in which the public may access proposed curriculum before a decision is made on adopting the curriculum. Policy—600.06—School Library Media Selection and Review

The policy committee is recommending changes to acknowledge a school library is distinguishable from a public library, modified language to describe patron access, and language to expand the self-selection provisions allowing students to place a hold or a parent/legal guardian to restrict access to a title. The Board requested the policy committee discuss including a definition for age appropriateness in the exhibits and the membership of the challenge review committees. C. Introduction of proposal for adoption of new District wide instructional materials - Amber Roderick-Landward, ISD Director The curriculum adoption process is a 25-step process and the first 17steps are completed prior to the first reading of the Board. Dr Roderick-Landward provided a curriculum overview of the rationale, summary of evidence, curriculum features, what sets the curriculum apart from others and curriculum limitations for the proposed adoptions for Chemistry, Physics and Elementary English Language Arts (ELA). The districtwide primary curricula are being proposed for implementation beginning in the fall of 2022.
