1. Study Session - 5:30 pm

A. Update on Strategic Planning – Superintendent Rick Robins

Mr. Drew Schanz, a consultant with Education Elements, recapped the progress that has been made on Strategic Planning since May 2021 to the present. He explained some common pitfalls to avoid during the decision-making process. The current information Canyons is utilizing in the decision-making process includes Synthesized Strategic Plan Content (Version 1), which was created with feedback gathered from Steering Team; Planning Team workbooks; Stakeholder engagement data; and the Accreditation Report. Education Elements will facilitate a workshop with the Board and Superintendent's Cabinet to review the latest version of the Strategic Plan's content and future steps for the process. B. 2022 Legislative Update – Charlie Evans, Director of External Relations and Susan Edwards, Public Engagement Coordinator

Mr. Evans indicated it was the first day of the Utah Legislative session. A resolution repealing the Salt Lake County mask mandate statewide passed in the Senate and will now move to the House of Representatives. Senate Bill 113 has been presented to address the test to stay protocols.  C. Construction update for Glacier Hills, Peruvian Park and Union Middle - Leon Wilcox, Business Administrator

The Peruvian Park Elementary construction has had supply chain issues with steel products for the new building, and it is anticipated the school will not be completed until September 30, 2022. The students and staff will remain at the Crescent View building for the start of the 2022-2023 school year. The construction is within the approved budget.

The Glacier Hills Elementary construction is currently on schedule to be completed for the start of the 2022-2023 school year. Additional contingency funding in the amount of \$555,000 is needed to cover the cost of steel and other metal price increases.

Union Middle School is scheduled for completion in August 2023 and 50% of the approved contingency funds has been used to cover increased cost of steel and electrical materials. Presentation available on BoardDocs.

7. New Business

A. COVID 19 Update – Superintendent Robins

Superintendent Robins reported the Salt Lake County Health Department has reset all school district dashboards to zero following the long weekend and remote learning day. A high number of employee absences due to illness is creating difficulties in staffing throughout the district. The district provided a vaccine booster clinic for employees last Friday, raising employees boosted to 43%, and employees with the first two vaccinations is over 80%.

The Administration is recommending placing all schools in the District in the Tier III status for COVID-19 response. The protocols include strongly encouraging anyone with COVID-19 symptoms to stay home, limiting assemblies, field trips and dances, encouraging elementary schools to increase keeping students in cohorts, and limiting volunteers and visitors. The District will continue to provide the drive-thru COVID-19 testing clinic for students and employees who are symptomatic. This will be in effect until Sunday, January 23, at which point Administration will evaluate available data and determine any additional steps that should be taken.

The Superintendent will report at the next Board meeting on February 1, 2022 on the remote learning day expectations and what is happening throughout the district on those days. Discussion available on BoardDocs.

B. Consideration for adoption of a resolution for the Board of Education of Canyons School District, Utah authorizing the issuance and sale of not more than \$70,000,000 principal amount of its Refunding Bonds, Series 2022 and related matters (Second Reading, Action Requested) – Leon Wilcox, Business Administrator

There were no changes since the last reading. Next steps include meeting with the bond ratings agencies on January 20, 2022 and the sale of refunded bonds in mid-February. The district will look to refund bonds issued in October 2013 in one year from now and bonds issued April 2015 in two years from now. C. Proposal for adoption of new District-wide instructional materials (Third Reading, Action Requested) - Amber Roderick-Landward, ISD Director

CSD is considering adoption of new District-wide instructional materials for elementary English Language Arts and high school Chemistry and Physics. Dr. Amber Roderick-Landward presented data from several districts that have implemented various versions of the elementary school ELA

curriculum, Wonders, which gives an idea of trends in student proficiency data for English Language Arts for 3rd, 4th & 5th grades combined.

Dr. Amber Roderick-Landward reviewed feedback received from stakeholders who have had digital access and print access of proposed instructional materials since December of 2021. Parents, stakeholders, and teachers were notified of the curriculum recommendations and provided an opportunity to review the materials through general news stories, websites, social media, flyers, Board meeting, BoardDocs, newsletters, SCC and PTA meetings. In the formally submitted feedback, 95% were positive comments about Wonders and 95% were positive about the Core Phonics program. There were questions about professional learning for teachers and what parent training would look like as well as initiating collaboration to support a student who is blind.
