B. Canyons Online Update – Principal Michelle Shimmin

Canyons Online provides a pathway for students who are looking for flexibility in schedule, mental and emotional support and a physically safe learning environment. There are currently 346 students participating in the K-8 program and 390 students are expected to begin the final term with 26 students on a waiting list. Ms. Shimmin reported the current state of the program for the Online K-8 and the Online High school program, in what is offered currently, what they have learned this year and what suggested next steps are for the program. She indicated that Arizona State University has been instrumental in providing feedback for the program and training for the teachers. C. COVID 19 Update - Superintendent Robins

Superintendent Robins reported that the COVID-19 positivity rate continues to decrease among students and staff throughout the district. He expressed appreciation to teachers, staff, parents and the Board for their patience and countless hours of service during the pandemic. The district COVID-19 testing clinics will close and nurses will only provide testing as needed at schools. D. Discussion on virtual learning days for the remainder of the school year (Possible Action) – Superintendent Robins

The Superintendent expressed that the importance and focus of in-person learning has been a priority for the school district throughout the pandemic. The purpose of virtual learning Fridays is to address the additional work required for teachers to support student learning through Canvas, LETRS training, and mental health of students, teachers, and staff. After some discussion, the Board allowed its previous decision for a Virtual Learning Friday in March and April to stand. E. Consideration for adoption of a resolution for the Board of Education of Canyons School District, Utah authorizing the issuance and sale of not more than \$55,000,000 principal amount of its Refunding Bonds, Series 2022B and related matters (First Reading) – Leon Wilcox, Business Administrator

The recently approved bond refunding transaction was issued on February 9, 2022, with the sale of nontaxable bonds issued in 2012. The refunding of the bonds will save Canyons District approximately \$7.8M. The second bond refunding proposal includes issuing approximate \$51M of taxable bonds to refund bonds issued in 2013 which cannot be refunded with nontaxable bonds until 2023. The Federal Reserve Bank has indicated multiple interest rate increases are inevitable in the next 12 months. The issuing of taxable bonds now is expected to bring a much greater financial benefit than issuing nontaxable bonds in a year from now. The expected savings will be between \$4M – \$5M. The Administration is requesting Board approval for the resolution at the March 1, 2022 Board meeting and the
