6. New Business Items

 A. Policy Update: Policy—300.07—Student Conduct on Buses; Policy—600.06—School Library Materials Selection and Review (Third Reading, Action Requested) – Jeffrey Christensen, Assistant Legal Counsel

There were no questions or discussion regarding the Student Conduct on Buses policy.

Mr. Christensen reviewed the philosophy and purpose of the School Library Materials Selection and Review policy and the proposed revisions. The Board of Education recognizes school boards have broad discretion in the management of school affairs and the selection of library materials for school libraries. The board adheres to constitutional and first amendment principles. The policy addresses the reality that a school library is distinguishable from a public library because of the unique role in support of equitable access to information and education of minors. The purpose of the policy is to balance in a public entity, the right of students to access information and at the same time protect minors from sensitive materials. This policy is not intended for any specific group but intended to govern the public system in a public school district. Mr. Christensen reviewed the revisions to the policy and how they were developed. He explained in detail the flow charts for exhibit 1, which guides a book review for sensitive materials (including the bright line rule), and exhibit 2, which illustrates the avenues for parent requests regarding concerns with books in libraries. He reviewed the composition of the school level challenge committee, which is comprised of a school administrator, a licensed teacher, a teacher librarian, or the district library media specialist, as well as two parents or legal guardians from the school community council, or other volunteers at the school.

<u>MOTION:</u> Mont Millerberg moved to approve Policy Update: Policy—300.07—Student Conduct on Buses; Policy—600.06—School Library Materials Selection and Review. Amber Shill seconded the motion. The motion passed unanimously.

There was discussion to the motion about potentially adding a permanently restricted access as one of the options for school level challenge committees. The motion was not modified to incorporate that idea.
