1. Study Session - 5:37 pm

A. CSD Equity Steering Committee Report – Superintendent Rick Robins

The Equity Steering committee's purpose is to develop guiding principles of equity. This team will serve to inform and recommend to the Board of Education processes to advance equity by ensuring all student populations participate, access, benefit and thrive in Canyons School District (CSD). The committee recommends that an equity initiative be embedded in the accreditation process underway this school year. To more fully undersand the equity challenges and successes, it is recommended that an assessment/audit be performed as part of the the accreditation process. A focus on financial resources, student access to high quality instruction, a comprehensive review of school names, mascots and traditions, student access to early learning opportunites, parental engagement and governance regarding mission, vision and policy will be conducted during the audit.

A discussion about the Board's Student Advisory Council resulted in expanding from the five traditional high schools to include a representatition from Diamond Ridge and increase to four student representatives from each school. The Board suggested the Student Advisory Council include broad diversity and be selected by school administration.
