# 1. Closed Session - 4:30 pm

# 2. Study Session - 5:30 pm

A. Board meeting logistics – President Nancy Tingey

The Board of Education discussed the new logistics of the Board Study room which have been upgraded to provide live streaming. B. Arts Consortium report – Sharee Jorgensen, District Art Specialist

Ms. Jorgensen reviewed that the Arts Consortium committee was formed in 2009 which was the first year of the district. The committee continues to meet quarterly and the purpose is to promote the arts and provide recommendations in improving arts opportunities within the

district. Partnerships within the community have been created through the committees' efforts. Arts are currently considered electives in the district.

Dr. Lora Tuesday Heathfield, PhD and Dr. Julie Stefan-Lindsay, EdD, from the Canyons Instructional Supports Department, reported the CSD electives survey results for the Middle and High Schools in the district. The purpose of the survey was to identify students interests and barriers that may prevent students from taking elective courses.

The Middle School survey had an excellent response rate. The High School response rate was very low and, as a result, the results may not necessarily represent CSD high school students as a whole. Generally, the highest interest was in Visual Arts, Pe/Health, CTE, and world Language electives. The primary reasons students are making the decision to not take Arts electives are not enough room in their schedule, schedule conflicts, not classes of interest, and advice from family. A high number of students are not taking Art electives due to fear of "not being good at it". The survey results indicated students value Art and other electives, and students are satisfied with the elective options at their school.

There were several takeaways and recommendations given to explore why students are not choosing Art electives and how communication could be improved to explain the purpose of electives. C. Draper Park schedule discussion (First Reading) - Cindy Hanson, School Performance

Ms. Hanson's presentation provided an overview of schedules, elective options, FTE allocations, academic performance, intervention classes/supports, acceleration classes/supports and a few differences between a 6 and 7 period schedule.

The Board of Education would like additional information about time allotted to teach curriculum, schedule related expenses, schedules of schools outside of the district, what accelerated options are offered, academic data from when the school on the 7 period and 6 period schedule., DLI and FTE's, input from the community, and information about a 5x5 schedule. #### 8. New Business

 A. Late start or early out proposal for collaboration and professional learning communities – School Performance

The purpose of the late start or early out would be to establish a district-wide, common block of time for teachers to work in high performing PLC's and ensure collaboration time for teachers at all grade levels. The teachers would use the time to engage in PLC work focused on student/teacher data, problem solving and instruction preparation. Both the early out and late start options would have at least a 4-hour student academic block of time, lunch and teacher collaboration and preparation time. Aligning the times throughout the district eases transportation constraints under the current model and may save money. The recommendation is to adopt a common early out on Fridays. The Board asked for additional information about instructional time, kindergarten schedule, how the planning time would be used, and feedback from the community. B. Student Discipline Update – Brian McGill, Director of Student Services

Dr. McGill defined discipline as, "a system consisting of a code of conduct, consequences or accountability metrics and behavioral strategies to regulate students and keep the school classroom in order." He reviewed and explained the discipline trend data for the last 5 years on all levels. Restorative practices are focused on how to improve and repair relationships between people and communities. The purpose is to build healthy communities, increase social capital, decrease crime and antisocial behavior, repair harm and restore relationships.

There is an increase in discipline referrals and chronic absenteeism has nearly doubled since the 2018-19 school year. The administration will work on strategies to address these issues. He reviewed the Utah Portrait of a Graduate (UPOG) mastery characteristics as a model for developing positive behavior in students. The Student Service Department priorities include health and wellness of all students and CSD employees, increase resources, evaluate and improve school-based supports, align skill development with UPOG, and align resources, funds, and other needs with the new board strategic vision plan. D. 2022-23 Fee Schedule (Second Reading) - Leon Wilcox, Business Administrator

Mr. Warwood, Director of Accounting, presented the proposed fee schedule for elementary, middle, and high schools. The District is proposing to reduce registration fees for the 2022-23 school year in anticipation of the state limiting general fees as soon as the next legislative session. Also, starting in the 2022-2023 school year, general textbook fees may not be charged. The District will now cover those costs. Mr. Warwood reported that the fees collected from basketball concessions would not be enough to cover the cost of referees. He indicated the other changes to the fees schedule presented at the March, 1, 2022 Board meeting remain the

same. Efforts will be made to communicate the proposed school fees schedule to school communities and invite them to provide feedback prior to the next board meeting. Presentation available on BoardDocs.
