D. Midvale area elementary school's boundaries (Second Reading) – Leon Wilcox, Business Administrator

Mr. Wilcox reviewed the communication process that has happened through meeting with SCC's and open houses for the public at Midvale Elementary, Midvalley Elementary, East Midvale Elementary and Copperview Elementary. The presentation made at each school is available on BoardDocs, March 29, 2022 Board meeting. In addition, communication has been sent through post cards mailed to the Hillcrest feeder system, flyers have been distributed by schools, email, text message, social media, posters and videos available through the web portal. In compliance with the Utah Code SB245, the first reading occurred on October 19, 2021, more than 120 days from the proposed adoption date, as well as meeting with Midvale Mayor Stevenson on January 13, 2022 and providing the opportunity for public comment at three Board meetings. The implementation of the new school boundaries would be for the 2023-2024 school year.
