9. New Business

A. Draper Park Middle school-day schedule proposals for 2023-24 school year (Third Reading, Action Requested) – Superintendent Robins and Cindy Hanson, School Performance

Ms. Hanson provided an overview of the 6 and 7 period schedules. The 6 period day was designed to provide additional time to utilize interventions in the classroom for reteaching, reviewing, helping students and supporting independent practice. In a 7 period day these interventions will be provided in specific classes rather than in each core class. Elective options were identified and presented for both 6 and 7 period schedules across CSD middle schools. There are many of the same electives offered across all middle schools. The 6th grade primarily offers introductory elective classes and 7th and 8th grades offer more advanced and varied choices. All grades offer the state-required elective classes. Links were provided for Middle School registration cards and Middle School Arts/Elective survey results.

<u>MOTION:</u> Amanda Oaks made a motion to move Draper Park Middle School to a seven period schedule for the 2023/24 school year, and request that the school's administration

begin right away to prepare for that and determine what kind of 7 period schedule will best fit the community. Holly Neibaur seconded it. The motion passed unanimously. Presentation available on BoardDocs.

1. Presentation of Final FY 2021-22 Budget and FY 2022-23 Budget Mr. Wilcox, Business Administrator, presented the final budget for the fiscal year 2021-2022. The general revenue budget had a \$12.2M increase in federal funding from ESSER's and an Electronic Connectivity Grant. There was a \$4.0M increase in State funding from carryovers and a \$3.6M increase in local funding due to Basic Rate property taxes. The general expenses had an additional \$7.1M for curriculum and Chromebooks from ESSER's funding. The budget also included extra teaching and support positions funded by ESSER's and a March bonus to employees. The increase of inflation, fuel and utilities were also additional expenses. The 2021-22 final Capital budget showed an \$11.1M increase in bond projects as less work was completed in FY21 than anticipated due to supply chain delays and more work was completed in FY22. Projects are still within the established budgets.

Mr. Wilcox presented the proposed budget for the fiscal year 2022-2023. The District's General Fund is supported by local, state and federal funds used to support the operations of the District such as teacher salaries, benefits, utilities, supplies with an estimated total budget of \$347,356,000. The majority of the General Fund is spent on instruction with 88.1% of the fund going towards salaries and benefits. He highlighted portions of what is included in the budget such as state funded WPU increase of 6% and other state increases, the budget is within the certified property tax rate, new growth, and the negotiated employee agreements. Additional items include the adjustments to the ESP salary schedule lanes 1-3, class-sizes remaining the same, increases for school supplies and utilities, ESSER funds for CSD online and instructional and support services at schools, teacher personal professional development, and full-day kindergarten at seven schools.

The Capital Outlay fund is financed primarily with local property taxes for acquiring building sites, building or remodeling facilities, and procuring equipment and vehicles and has an estimated total budget of \$56,835,000. The bond funded projects will include Union Middle school rebuild and finishing the rebuilds of Glacier Hills and Peruvian Park. Capital funded projects include small capital improvements, districtwide improvements, information technology, school equipment and ten school busses. A summary of the outstanding debt was presented. The USDA waiver for free lunch was not extended and the District will start charging for lunch next school year. The labor shortage will require all payments to be made online through Skyward. The inflation of food costs continues to be a concern. FY22 is the last year for payment on the Jordan School District debt. <u>MOTION:</u> Amber Shill moved to adopt the 2022-23 budget for revenues and expenditures for each fund as presented and adopt the tax rates as follows: 1) Set the tax rate at the Certified Tax Rate as calculated by the State Tax Commission. Authorize any revenue budget adjustments to reflect funds received from the Certified Tax Rate. 2) Set the State Basic rate at the rate determined by USBE when received. 3) Set the debt Rate to generate sufficient revenue to pay debt service, but not to exceed 0.001565. Mont Millerberg seconded the motion. The motion passed unanimously.
