6. New Business Items

A. Update on 2022-2023 Volunteers and Introduction of Region 17 PTA Board – Susan Edwards, Public Engagement Coordinator--Charisse Hilton presented instead of Susan Edwards.

Region 17 PTA is a division of Utah PTA that serves Canyons School District. The Region 17 PTA Board oversees the 43 existing PTA's and PTSA's in the District. The Region 17 Board fills in the gaps where PTA's and PTSA's need assistance. The volunteers doing PTA service collectively reported serving a total of 60,591 hours. Terri Francis, Region 17 PTA Board Director introduced the Region 17 PTA board members, Liz Miles-Associate Director, Amourette Bradley - Secretary, Sheila Armstrong - Treasurer, Dr. Rick Robins - Administrative V.P., Susan Edwards - District Representative. CSD is one of the only Districts to have liaison between the District and PTA and that collaboration is extremely valuable. Ms. Francis expressed appreciation to Canyons Board of Education for supporting parent engagement through the services rendered by the PTA.

B. Districtwide Constitution Day observance plans – Dr. Robert Dowdle, Assistant Superintendent

All schools receiving Federal funds are required to teach about the Constitution on the designated day. A short video explaining Constitution Day from school leaders and what it means to them will be shown to students at all levels. C. Tier One Life Skills supports for students beginning in the 2022-23 school year (Second Reading) - Dr. Brian McGill, Director of Student Services

The Board was presented two options for reviewing and field-testing the Tier One Life Skills supports for students. The first option would overlap the review and field-testing steps. Option 2 would run the review and field testing separately. The review criteria for both options would be comprised of content, digital citizenship, Utah code, CSD policy, pedagogy, and parent/guardian reviews. The field-testing steps would include optional school participation, district created and provided lessons, teacher review of lessons prior to instruction, teachers sending lesson to parents prior to instruction, and the option for parents to opt their child out of the lessons.. The feedback collected through the field-testing would then be brought back to the Board for a full curriculum adoption discussion and process before implementation for the 2023-2024 school
