3. New Business

A. Appointment of New Superintendent

President Tingey recognized board members in attendance as well as those joining electronically. She noted that normally schools would be full of students, however, the dismissal of Utah schools to slow the spread of COVID 19 has changed that and students are currently engaged in distance learning. She expressed appreciation for teachers who quickly pivoted to providing high quality instruction and caring interactions with students. The Board of Education pressed forward with the vitally important assignment of finding a new Superintendent, in a timely manner to ensure a seamless transition when Superintendent James Briscoe retires at the end of June 2020. The Board's search for a Superintendent began in February through surveys, town hall meetings and discussions with patrons, employees and students' feedback was gathered on traits and characteristics that our community wanted in a Superintendent.

<u>MOTION:</u> Clareen Arnold I move, whereas the Board of Education seeks a Superintendent who has a strong focus on increasing student growth and achievement; is skilled in building and maintaining positive relationships in the

community; is dedicated to providing a high quality of service to patrons who seek information and assistance from the District; has a commitment to ensuring the prudent use of public funds; and will execute the Board or Education's vision, mission, and facilities plan with fidelity; I move that the Board of Education, which has been duly elected to represent the will of the people, approve the contract and appoint Dr. Rick L. Robins as Superintendent of Canyons School district, his service to begin July 1, 2020. Amber Shill seconded the motion. The motion passed unanimously by a roll call vote.
