#### 2. Study Session - 5:15 pm

A. 2020 Legislature Update – Charlie Evans, Director of External Relations and Susan Edwards, Public Engagement Coordinator

Mr. Evans updated the Board of Education on the current education bills being discussed during the Utah Legislative session. He indicated bills will be identified in red for the first day

they appear on the CSD bill tracker. The Board of Education requested to add a column that comments about the bill. The Board also asked the administration to pay attention to the bills which pertain to their respective departments. B. Update on new State requirements for teacher licensure – Steve Dimond, Director of Human Resources, Jo Jolley and Sally Sansom Human Resources Administrators – Recruitment Ms. Jolley reviewed the new licensing structure designed by the Utah State Board of Education (USBE). The structure has been reduced from 13 types of licenses to 3 types of licenses which are a Professional Educators License, an Associate Educator License and an LEA specific Educator License. The Board of Education is responsible for adopting an LEA specific educator license policy and approving a list of employees who are receiving an LEA specific license and endorsements in an open board meeting.

Ms. Sansom reviewed examples, requirements, USBE training modules, mentoring program, school website requirements and clarification statement. The recommendation was made to have the school website requirement consistent throughout the District. Presentation on BoardDocs.

C. Policy-400.216 LEA Specific (Canyons) Educator License Requirements (First Reading) – Jeff Christensen, Assistant Legal Counsel and Steve Dimond, Human Resource Director Local Education Agencies (LEA) have been instructed by the USBE to adopt a policy regarding LEA-specific Educator Licenses. Mr. Christensen presented to the Board of Education a draft policy to review. USBE will now require an LEA-specific Educator License/Endorsement be approved by the local LEA/Board of Education in an open public meeting. A request was made to include the acronym APPEL (Alternate Pathway Professional Educator License) and define coaches in the policy as mentors. Documents Available on BoardDocs.

A. School Emergency Closing and Make-up Day

The calendar committee studied the 2019-2020 calendar, surveyed teachers and proposed Presidents Day, February 17, 2020 on the approved calendars for a make-up day in the event of inclement weather.

<u>MOTION:</u> Nancy Tingey moved to approve to hold school on Monday, February 17, 2020, Presidents Day, as designated on the Board approved District calendar with the direction to Superintendent Briscoe to contact the State Superintendent to see if there is any opportunity for allowance that could be granted in writing before the end of the day, Friday, February 6, 2020 in order to notify the public, which allowance would be accepted by the Board. B. Elementary School Dual Immersion Committee Proposal (Second Reading) – Dr. Amber Roderick-Landward. Director of ISD

The committee's recommendation is to add two additional, Spanish Elementary DLI programs, with implementation beginning in the 2020-2021 school year. The proposed locations for the additional programs are Altara Elementary and Midvalley Elementary. A lottery would be conducted for those who are interested in enrolling in these programs. She reviewed a timeline for August 2020 implementation and projected costs. The Board of Education requested additional information and community notification of the schools that are being considered in order to gather feedback. C. Update on Superintendent Search Process

Mr. Haney, Director of Communications provided a timeline for the search process as discussed by the Board of Education in a special Board Study Session, held on January 29, 2020. The directive from the Board included opening the application window, launching marketing materials for the website, developing a brochure, and conducting a national advertising campaign beginning on February 10, 2020. There was a discussion about extending the application window to be open February 10, 2020 and close on March 13, 2020 based upon recommendations from the USBA representative Richard Stowell. Mr. Stowell also suggested including a direct mailer to broaden the exposure for the search. Surveys will be sent to parents, employees and Administration to provide feedback on characteristics desired in a Superintendent, what the greatest challenges will be for CSD in the next ten years and what is going well at CSD. Three Town Hall meetings are scheduled for February 25 at Jordan High, February 26 at Corner Canyon and February 27 at Albion Middle school, from 6:30pm - 8pm. The Communications Department will facilitate the meetings and members of the Board of Education will be present to answer questions and receive community feedback.
