Update on Hillcrest High School Summer Program & Student Progress Greg Leavitt, Principal, Hillcrest High School and Sarah Newberry, Assistant Principal, Hillcrest High School Principal Leavitt and Assistant Principal Newberry reported on the success of the Hillcrest summer program. Number of students that attended and completed the program, subjects taught and improvements in GPA were presented. Digital Teaching and Learning HB277 Dr. Darren Draper, Director, Education Technology Dr. Draper updated the Board on the timeline and the plan for grant funds which will be between \$600,000 to \$700,000 for FY17. Areas of focus will be to improve science scores and help teachers use technology better. Teachers will have the opportunity to earn certifications, stipends and SUU credits which can lead to an EdTech endorsement.
