

# CANYONS SCHOOL DISTRICT MINUTES OF BOARD OF EDUCATION MEETING February 21, 2017

The Board of Education of Canyons School District met in a study session and business meeting on Tuesday, February 21, 2017 beginning at 5:15 pm at the Canyons Administration Building - East, 9361 S. 300 East, Sandy, Utah 84070.

## 1. Study Session – 5:15 pm

A. Legislative Update – Charlie Evans, Director of External Relations

Charlie Evans updated the Board on two bills, SB80 and SB240. SB80 has passed the Senate and is with the House Education Committee. This bill would create two classes of school districts - winners and losers. This will undermine the WPU to where it would be almost meaningless. Some school districts are actively promoting SB80. Representatives that are opposing this bill are Bruce Cutler, LaVar Christensen and Marie Poulson. Please contact these representatives and thank them for opposing this bill. Speaker Hughes is actively helping us work with the education committee. The second bill that was discussed was SB240. Senator Fillmore sponsored SB240 which would allow an SCC to go around the local school board and go directly to the State school board to get a charter school. This bill also allows some waivers on teacher evaluations. Nancy Tingey mentioned two bills that address the accountability of education. SB220 by Senator Millner would create a statewide accountability system. Senator Poulson has a bill to remove the grading system of schools. There is a likelihood that these two bills will merge.

B. Hillcrest Feeder System Pilot / Proposal to Continue - Dr. Kathryn McCarrie, Assistant Superintendent and Greg Leavitt, Principal, Hillcrest High School & HHS Feeder Schools

Dr. McCarrie reminded the Board of the proposal that was presented last February requesting extra funding in critical areas for the Hillcrest feeder schools. The funding was for a Hillcrest High summer program for incoming ninth graders and additional administrative support. Also requested was additional achievement coaches for Midvale Midvale Elementary, Copperview Elementary and East Midvale Elementary. The Principals of these schools gave an update on the benefit of the program and asked that the funding support continue for the upcoming school year. Elementary principals Christy Webb, Chip Watts and Justin Pitcher and Middle School Principal Wendy Dau presented data and discussed the benefits of the additional achievement coach. Hillcrest High Principal Greg Leavitt presented data on the summer school initiative. There are already fifteen students that want to attend the summer program this year. The Board asked questions about options for the program and adding higher grades to the program in the future. AmeriCorps volunteers work with the students and the assistant principal. Leon Wilcox mentioned that the program is mostly cost neutral. This will be a line item on the budget. Documents are available on BoardDocs.

C. Update on Diamond Ridge High School – Karen Sterling, Director of Student Advocacy & Access Amy Boettger, Principal of Diamond Ridge was available to answer questions from the Board. Karen Sterling presented the benefits of alternative high schools and a history of Diamond Ridge. The main goal is to increase the graduation rate. Diamond Ridge is a District school, not a boundary school. Staffing and FTE numbers have grown over the years. The State has an alternative accountability system for alternative schools, they do not get a letter grade. Potential growth was shown and numbers of students that could possibly attend were discussed. This is for students that want a fresh start in a safer, smaller environment. It is better to have alternative high schools in a separate building rather than part of another high school. The CTEC location is not ideal. In the future, we can look at options and make this part of the District plan. They are going slow and building a strong foundation and are in the process of accreditation. Board members asked questions about options to get the school a building. Diamond Ridge has a lot of pride in their school. Presentation is available on BoardDocs.
