## 2. Study Session – 5:30 pm

A. Update on Communications Plan for the Bond Election – Jeff Haney, Director of Communications & Public Relations

The Communications Department shared information with the Board detailing the weekly breakdown of events, media coverage, mailings, timelines and deadlines of the Informational Campaign for the 2017 Bond. There is at least one event every day, between now and the election, where bond information will be provided. To help inform on the bond there will be leaflets, car stickers, and signs on CSD busses. September 19, 2017 will be a public hearing on the bond followed by the pro and con statements being read at the October 17, 2017 business meeting. November 21<sup>st</sup> will be a special Board Meeting to canvas the results of the election. B. Board of Education Vision & Mission Indicators & Student Achievement- Dr. Hal Sanderson, Director Research & Assessment

Dr. Hal Sanderson reviewed the Board's mission and vision statement, indicators and tenets. The 'Annual Review of Indicators' presentation of student achievement data focused on the goals for 2018. Dr. Kathryn McCarrie and Dr. Amber Roderick-Landward were in attendance and shared information that was pertinent to the presentation. Indicator data was presented on Kindergarten DIEBELS, Grades 3, 5 and 8 DIEBELS, SAGE, Reading Inventory and Math Inventory and High School Grade 11 ACT Composite Score and graduation rate. A new PBIS indicator for school climate and student behavior has been added this year.

There are many factors to be considered and there is always fluctuation in data. Canyons School District data is moving in a positive trend and compares favorably to the State and four other school districts in the area. The comparison charts were discussed and questions from the Board were addressed.

A couple of key points were made. DIEBELS benchmarks change from fall to spring to indicate learning within the school year. CSD implemented an updated math curriculum last year and the increased scores show teachers embraced the new program. After reviewing the data, the Board discussed how goals were set and the possibility of revisiting some goals after 2018.

While there is much to celebrate, there is still much room for improvement. The administration will look deeper at areas of concern including 8<sup>th</sup> grade SAGE and 11<sup>th</sup> grade ACT. The Board thanked Dr. Sanderson for the information. The Board will receive Part Two of Dr. Sanderson's presentation at a future board meeting. Presentation is available on BoardDocs.
