

# CANYONS SCHOOL DISTRICT MINUTES OF BOARD OF EDUCATION MEETING **December 4, 2018**

The Board of Education of Canyons School District met in a business meeting on Tuesday, December 4. 2018 beginning at 5:45 pm at the Canyons Administration Building - East, 9361 S. 300 East, Sandy, Utah 84070.

#### 1. Study Session – 5:45 pm

- A. AP, ACT, Graduation Rate Dr. Hal Sanderson, Director of Research and Assessment Mr. Sanderson presented statistics for high school AP, ACT and Graduation Rate. Canyons School District continues to be above the State and National averages in ACT composite scores as the average ACT composite score for CSD students is 21.6. Canyons AP results show that 35% of students are participating in taking AP tests with a 71% pass rate. This is above state and area averages. The CSD graduation rate is on the rise with the Class of 2018 at 89%, a 3% increase from the Class of 2017 at 86%. Presentation and Documentation available on BoardDocs.

- B. 2017-18 Comprehensive Annual Financial Report Leon Wilcox, Business Administrator Mr. Wilcox presented highlights from the 2017-18 Comprehensive Annual Financial Report. He reported that CSD had a clean auditor's report. The fund balance staved at \$75 million and factors into the District maintaining a AAA bond rating. The District total spent for FY 2018 was \$258 million, \$6 million under budget for the year. The District's taxable value has grown from \$15.6 billion in 2012 to \$22 billion in 2017. - C. Canyons School District Proposed Digital Initiative (First Reading) -Scot McCombs, Director of Information Technology Mr. McCombs reported that during online registration parents were prompted to complete a survey to determine if internet access was available in their home. Results identified that 10%

of the students who responded to the question, 430 of whom are high school students, do not

have access to internet at home.

Mr. McCombs proposed that the District explore options for affordable Chromebooks and internet hotspot access, to help reduce the digital divide for students who qualify based on need. Mr. Wilcox noted that the State Legislature increased Digital Teaching and Learning funding which would be available to use for this initiative. The Board asked Mr. McCombs to acquire more information and to propose a pilot program. Mr. McCombs will report back in February with a proposal outlining a pilot program with RFP results for a commitment from a cellular service and a sliding scale user cost based on household need. Dr. Stensrud reported that the calendar committee has accomplished the Board's request to complete the school year in May. They were able to maintain the recesses and the Parent Teacher Conferences. The committee was also able to better align the Brighton High School calendars with the other schools in the District. B. Responsive Services Update (Student Safety) - BJ Weller, Director of Responsive Services Responsive Services has been focused on school safety and collaborating with other departments to build systems to provide more accurate data.

The department is broadening the scope of school mental health specialists and increasing supports to teachers and the classroom. A behavior screener has been implemented for all Elementary schools. A new youth academy was opened this year that serves 6-12 grade students upon referral. Staff trainings have been added to address: suicide prevention; trauma informed practices; de-escalation strategies; 504 accommodations; attendance and discipline and behavior interventions. He outlined the additional staff needs that will further help in accomplishing effective outcomes. The Board requested information regarding the cost to meet additional staff needs throughout the District. Presentation available on BoardDocs.
