#### 1. Study Session - 5:00 pm

During Utah College Application Week, students are given time and assistance to apply for college during instruction time and in some cases receive financial help from Canyons Education Foundation to pay for the application fees. Ms. Gillett introduced Jordan High school's Latino's in Action program, Advisor Matt Bell, Co-President Luis Alvarez, and Co-President Yuritzi Huerta. The students expressed their appreciation for the opportunity to apply for college and the chance to have a better future by receiving more education. During UCAW week, 1,400 Canyons School District seniors applied to at least one college.

Ms. Gillett reported on how middle school counselors are helping assist students with college and career readiness. Each year students participate in college and career exploration and planning. In 8<sup>th</sup> grade, students build a four-year plan in Skyward for 9<sup>th</sup>-12<sup>th</sup> grade years with the assistance of parents and counselor.

The Board of Education requested that Ms. Gillett come back to a future board meeting to report on how High School students are being prepared for college and careers.

B. Turnaround School Update – Joanne Ackerman, Director of Elementary Principals, Karen Sterling, Director of Student Advocacy and Access and Chip Watts, Midvale Elementary Principal

Karen Sterling, Director of Student Advocacy and Access introduced Midvale City Mayor
Robert Hale, who spoke to the Board of Education about ways Midvale City and the District
assist each other. Ms. Ackerman, Director of Elementary Principals spoke about how Friday
coordination meetings are helping impact Midvale Elementary in a positive direction.

Mr. Chip Watts, Midvale Elementary Principal introduced staff in attendance from Midvale Elementary. The staff is focused on restructuring to improve teaching/learning, increase social emotional supports and support parent involvement. The academic data Mr. Watts presented indicates that students are showing well above typical growth in most of the target areas. The social emotional support data shows a drastic reduction in tardies and a reduction in office referrals so far this year.

Ms. Beverly Herrman spoke briefly about Imagine Learning software program being used at Midvale Elementary which focuses on listening, speaking, reading and writing. The data Ms. Herrman presented shows students are closing the gap in these areas.

Mr. Watts continued his presentation, reviewing data and discussing strategies to address summer slide and the goal for students to be at grade level by the end of each year. Ms. Sterling indicated a reduction in Federal funding is a challenge for implementing additional programs. She suggested a task force take a look at options such as a modified year-round calendar to help sustain students' learning.

Concerns were discussed regarding teacher retention and separately tracking students who move into the school in later grades from those who attended Midvale beginning in kindergarten.

The District received formal notice that Midvale Elementary had not yet realized enough improvement to be removed from turnaround status. Ms. Sterling asked for a letter from the Canyons Board of Education to the Utah State Board of Education requesting an extension of time for Midvale Elementary to continue working on their goals.

C. Midvale Partnership for Students Success – Karen Sterling, Director of Student Advocacy and Access

Ms. Sterling's presentation was an update on the Midvale Partnerships for Student Success initiative. The state grant and local partnership embrace the school board tenets. The innovative work being done at Canyons is serving as a model to other districts throughout the nation. Katherine Zachara, United Way Director of Civic Partnerships, reported that United Way is working in partnership with Canyons School District to resolve complex problems through collective community solutions. The goal in this partnership is to improve education outcomes for students who are economically disadvantaged through cross sector collaboration that uses data to align and improve efforts focused on student success.

 The policies have been updated and procedures aligned for Work-Based Learning, Research Approval Process and Surveys and Eye Protection. Mr. Christensen did not receive any

feedback regarding the changes in these policies since the last reading.

B. This is a new policy which provides guidelines for the Board to use when presented with a tax increment financing project proposal. The Policy Committee received and considered feedback from local municipalities, and associations, as well as from the Board during recent study session discussions. There was no additional input regarding this policy since the last reading.

<u>MOTION:</u> Nancy Tingey moved to approve New Policy 200.5 Tax Increment Financing Project Agreements. Amber Shill seconded the motion. The motion passed unanimously.

C. Approval of 7<sup>th</sup>-12<sup>th</sup> grade Online Math Book proposal (Action Requested) – Dr. Amber Roderick-Landward, Director of ISD http://www.boarddocs.com/ut/canyons/Board.nsf/goto?open&id=B6A9LN7364B5 Ms. Roderick-Landward reviewed the rationale for adoption and implementation of Illustrative Mathematics in 7<sup>th</sup> and 8<sup>th</sup> grade and Mathematics Vision Project in Secondary I, II, III. She explained the alignment to the standards and integrated mathematics model as well as evidence-based instructional practices in mathematics. The curriculum provides the appropriate level of rigor to support mastery and sustained learning for all students including English language learners. Wendy Dau, Jordan High School Principal, presented specific examples she has observed from teachers who implemented MVP in the classrooms compared to those who stayed with the current curriculum. Mindy Robinson, Midvale Middle Principal, talked about how this curriculum is engaging students at a whole new level. She also expressed that while it is not a perfect curriculum it is allowing them to meet the needs of students at all levels of learning. Dr. Briscoe emphasized the importance of consistency in Math curriculum throughout the District in order to pull out of the stagnant student achievement growth.

Ms. Roderick-Landward reviewed the feedback from the math teacher survey. The majority of respondents do not feel that the current adopted resources align to the Utah Core Standards. High school teachers who responded are not using common materials. The majority of respondents who are piloting either Illustrative or MVP acknowledge the challenges of implementing new curriculum but have been pleased with the results. The majority of respondents who are not implementing either Illustrative or MVP are not interested in adopting new curriculum. Training in task-based learning and how to scaffold will be critical. Teachers who have attended district professional development have found it to be valuable. Allison Duncan, Instructional Supports Math Specialist, with her experience and expertise recommends Illustrative Math and MVP as a best practice for math instruction. Schools will have the option to have students use the online resource or purchase the soft bound workbook.

The land trust final reports have been submitted to the State. All schools were in compliance with the 10% funding carry over mark. In a recent state meeting Canyons was recognized as one of the few districts in the state to adhere to the carry over rule. All schools made expected or appropriate growth toward reaching their set goals.

Mr. Christensen reported that Dress code policies across the country are being revised to address discriminatory language, gender neutrality, and enforcement. Input concerning the dress code and its implementation was received from some of the assistant principals in the District and the CSD Student Advisory council. They suggested that language should not be gender specific, addressed the prohibition of wearing hats, and shared concerns about consistent enforcement of the dress code throughout the District. Mr. Christensen will have SCC's review the policy for additional input.

There were changes in the language and procedures of Student Automobile Use and Parking policy. Language was updated to allow each school to develop a parking and traffic plan at individual schools.
