http://go.boarddocs.com/ut/canyons/Board.nsf/goto?open&id=BD5R8H640B2E President Tingey declared the public hearing for the 2018-19 Final Budget and FY 2019-20 budget open.

 Presentation of Final FY 2018-19 Budget and FY 2019-20 Budget Mr. Wilcox presented a review of the FY 2018-19 Final budget. The original and final budget amounts were given on the General fund, Capital fund and Debt Service fund for Revenue and Expenditures.

The proposed revenue and expenditures were presented in chart format by individual funds for the FY 2019-20. The General fund is supported by Local, State and Federal funds which is used to support the operations of the District with expenses such as salaries, benefits, utilities and supplies. The majority of the General fund is spent on instruction with 89% of the fund going towards salaries and benefits. The budget includes the negotiated agreement with the CEA that all teachers receive a \$7,665 salary increase and Administrators as well as ESP's receive steps and a 3% COLA. The State WPU increase of 4.0% and TSSA of 4.9M are also factored into the proposed budget. The cost for Alta's Step2theU, Jordan's AVID, Hillcrest feeder and Midvale Elementary restructuring is included. The District Administration will continue to review all positions as they become open through attrition and reduce staff where possible. In addition, the consolidation of district level departments to one campus is expected to reduce expenses. Capital Outlay is financed primarily with local property taxes for acquiring sites, building or remodeling facilities, procuring equipment and vehicles. Bond projects, major small capital and other capital expenditures were reviewed such as the rebuilding of specific schools, remodels, lighting projects as well as districtwide upgrade to buildings, technology and equipment. A summary of outstanding debt, debt services payment and property taxes were presented. A proposed property tax increase would generate \$13.750 million to pay specifically for teacher salary increases only. C. Approval of FY 2019-20 Budget subject to Truth in Taxation Hearing on August 6, 2019 – (Action Requested)

<u>MOTION:</u> Amber Shill moved to 1) Adopt the 2019-20 budget expenditures and revenues for each fund as presented 2) Authorize a Truth-In-Taxation hearing on August 6<sup>th</sup> at 6:00 p.m. to set the property tax rates as follows: a) Basic School Levy – certified rate as determined by the Tax Commission and Utah State Board of Education b) Board/Voted Levies – a combined rate to yield an additional \$13,750,000 above the certified rate. These funds will only be used for teacher salary increases c) Debt Service Levy – sufficient to service debt requirements, not to exceed 0.001565 d) Capital Levy – the certified rate. Steve Wrigley seconded the motion. The motion passed unanimously.
