#### 2. Staff presentation on proposed tax increase

CSD Business Administrator, Leon Wilcox reviewed the process leading to this Truth-in Taxation Hearing which included a timeline of announcement and previous public hearings as well as the publications and communications to the public regarding this matter.

Mr. Wilcox explained that Utah law establishes a certified rate system for property tax which generates the same tax revenue for the taxing entity as the previous year, with an allowance for new property growth. There is no inflationary adjustment for the certified rate and property tax revenues. Local governments, including school districts, commonly increase property taxes every 5-8 years to capture the inflation. This adjustment to the certified rate has not been made by CSD since 2009 the first year of operations for the district. He presented statistics and survey results

regarding the teacher shortage in Utah. He also presented information showing the effect of the proposed tax increase on an average value home in Canyons District and a comparison of taxes and teacher salaries of CSD and other school districts in the area. The presentation contained information on how patrons may appeal the assessed value of their property at <a href="https://slco.org/property-tax/">https://slco.org/property-tax/</a> by September 16, 2019 and how patrons who qualify for a statutory tax relief can apply through the Salt Lake County Treasurer at <a href="https://slco.org/treasurer/tax-relief-applications">https://slco.org/treasurer/tax-relief-applications</a> by, September 3, 2019. CSD is proposing a property tax increase of approximately \$140 annually on the average home valued at \$421,000 in the district. All of the tax increase will go directly to fund the teacher salary increase.
