- A. Graduation Survey Results Update Dr. Robert Dowdle, Assistant Superintendent The high school principals from Alta, Brighton, Corner Canyon, Diamond Ridge/Entrada, Hillcrest and Jordan reported their respective school's graduation survey results as well as the creative ways seniors are being recognized during the school dismissal. They also provided feedback from Senior Class officers, SBO's and SCC's from each school. The seniors who participated in the survey indicated they would prefer a traditional graduation at a later date. The direction of the board to the high school principals was to provide a recognition and distribute diplomas to Seniors on May 28, 2020. The details will be determined by individual high schools within the guidelines of the County Health Department. The Board of Education requested principals move forward with setting a date for a traditional graduation ceremony, contingent on the allowances for group gatherings. The principals will work with Administration, Senior class officers and SBO's to determine specific plans for each school and create a way to contact students after the school year so by mid-summer they can determine participation level for a traditional graduation and celebrations. Policy 100.1 Board Governance, Electronic Board meeting provisions
The Governor's Executive Order issued on March 18, 2020 suspended certain provisions of
the Open and Public Meetings Act regarding electronic meetings. The direction was given
that if an organization's policy did not include a resolution or rule for electronic meetings that
the governing body adopt one. The policy draft includes provisions to conduct electronic
meetings, definitions and parameters on how to request a meeting, public notice and access.

B. Long Range Planning Committee Update – Board of Education Long Range planning committee

Superintendent Briscoe shared ideas on possible utilization of existing district facilities and land in new ways to strengthen programs and meet future needs of the district. He reported that the CTA program needs a new location and the CTE program is also in need of a significant upgrade. The committee has been exploring the possibilities for future use of the Crescent building and Bell View when it is available. A new housing development in Midvale will create the need to either adjust boundaries or provide pocket busing to accommodate the new students.
